EAST KERN HEALTH CARE DISTRICT AD HOC COMMITTEE REPORT

TOPIC: COMMUNITY COLLABORATION FUNDING

Ad Hoc Committee meeting was held on July 17, 2022, at 3 p.m. via Zoom. It was set up by staff, recorded, and transcribed.

SUMMARY:

EKHCD seeks to bring benefit to residents within our sphere of influence by partnering with other organizations to promote health and well-being.

One of the methods used to accomplish this goal is the EKHCD Community Collaborative Funding. This funding adapted a form developed by the Bank of the Sierra for their community grant proposals.

On December 7, 2021, the EKHCD Board of Directors awarded the California City Fire Department a grant in the amount of \$ 11,618.52 to purchase 4 portable ultra-sound devices to be used in the field by EMTs.

On May 3, 2022, the EKHCD Board of Directors awarded the California City Parks and Recreation Department a grant in the amount of \$5,907.91 to fund materials and lunch for the 2022 Summer Camp program to be held in Central Park.

Both organizations were invited to present requests to EKHCD. Because of the success of these actions, new organizations are approaching EKHCD to ask about the potential of applying for funding, and it is necessary to clarify our procedures so that we can be responsive and objective in our policy.

At the July 5, 2022, Board meeting the Ad Hoc Committee was established to review our policy and procedures for the EKHCD Community Collaborative Funding.

ANALYSIS:

Committee Recommendations:

- 1) Priority Board's fiduciary responsibility for the accountability of the usage of the funds.
- Develop acceptance documents that identify benchmarks of agreement and monitor usage of funds.
- 3) Create applicant check-off list of procedures and documents required.
 - A. Must explain community benefit and accessibility to all who are interested.
 - B. Must have a health and well-being focus physical, emotional, mental.

- C. Must present evidence of demonstration of community interest and need.
- 4) Create check-off list of requirements and reporting criteria for awardees when they accept the grant.

FUTURE ACTION STEPS:

- 1) Take to full Board for discussion on 7/19/2022
- 2) Schedule another Ad Hoc Committee meeting to incorporate Board direction and comments into notes
- 3) Refer notes to attorney to draft policy to be approved by Board.
